Defendant appeared in person

BRITTON: Registrar, if I could mention matter number 38 in your list?

REGISTRAR: Yes.

BRITTON: Miss Britton, I appear on behalf of the plaintiff. Mr Wilson is here in person.

DEFENDANT: Hey, Mr Bradford.

REGISTRAR: Mr Wilson, how are you?

DEFENDANT: I'm after trial by jury.

BRITTON: Registrar, it's our application for the matter to be referred to the Associate Justice. We wish to make an application for summary judgment.

DEFENDANT: You won't get summary judgment; that's illegal. I'm demanding my right to trial by jury. To deny trial by jury is treason and all the judges are thieves and traitors. We have liberty under Christ Jesus. As free men we all have the inalienable rights and that includes the right to trial by jury.

REGISTRAR: Mr Wilson, have you complied with Rule 29.2 in respect of a notice of motion and requisition for a jury?

DEFENDANT: I have put in a defence and that can only be heard by a jury. Nothing inferior. I do not accept the jurisdiction of the court. I challenge the jurisdiction of the court any time legal rights and legal procedures are violated. They have been violated against me in the last 13 years. I have never had a trial by jury. All those courts are kangaroo courts. I demand the right to trial by jury.

REGISTRAR: All I can do, Mr Wilson, is as I have on many occasions beforehand referred you to Rule 29.2.

DEFENDANT: A and you are committing treason by doing so.

REGISTRAR: All right.

DEFENDANT: Don't just shake your head. Haven't you got a conscience? Doesn't your conscience tell you what's right and what's wrong?

REGISTRAR: Ms Britton, have you filed a notice of motion seeking summary judgment?

BRITTON: No Registrar, we have not. We wish to make a verbal application in circumstances where Mr Wilson has no standing to defend the proceedings as an undischarged bankrupt.

DEFENDANT: That's a lie. That's a lie.

BRITTON: And we have some case law to rely on.

DEFENDANT: That's a lie. All the judgments against me have been totally illegal, kangaroo courts. They are void. Any trespass upon my property will be resisted. DEFENDANT: There must be a jury; nothing less.

MATTER INTERPOSED

DEFENDANT: Where is this Harrison character?

REGISTRAR: It's associate Justice Harrison, Mr Wilson, and I would ask you to at least be a little bit civil towards other human beings.

DEFENDANT: I'm being civil; you're being criminal.

REGISTRAR: Court 7F, Mr Wilson.

DEFENDANT: I asked you where is this person.

REGISTRAR: Court 7F. I told you, 7F.

DEFENDANT: What?

WILSON: I challenge the jurisdiction of the court.

HER HONOUR: I understood what you said.

WILSON: You are disregarding a legal procedure, this is a kangaroo court.

BRITTON: This is an unusual application, your Honour.

WILSON: I challenge the jurisdiction of the court.

HER HONOUR: Have you got evidence?

WILSON: This is a kangaroo court.

HER HONOUR: But if you are bankrupt you don't have a say.

WILSON: This is a kangaroo court. You are a thief and a traitor.

HER HONOUR: I don't think you files –
